CONTEXT

The College is committed to underpinning its activities through the values it espouses, namely to encourage social awareness and responsibility as well as promoting flexibility, maximising opportunities for social inclusivity and accessibility in Higher Education. Within that context, the College accepts that there may be circumstances where a temporary suspension of studies is warranted. Such a temporary suspension is granted on the grounds that the student is unable to engage effectively with their studies because of factors outside their control (including, but not limited to)

- Serious and persistent health problems,
- Disability,
- Bereavement or additional sole caring responsibilities,
- Serious financial problems,
- Unanticipated changes in a student's employment pattern.

POLICY STATEMENT

While the College normally expects learners to complete their studies within a single continuous period, it does recognise that there may be exceptional circumstances where that aim may not be possible. The College, in such circumstances considers applications for voluntary Suspension of Studies for a temporary and defined period and may grant such a suspension having considered the evidence presented to support the application. Learners should note that there is not an automatic right to suspend their studies. As a suspension of study will interrupt a student's progress on their programme, applications may be considered on an individual basis and will only be granted where there are reasonable grounds and supporting documentation (e.g. a report from a registered medical practitioner).

DEFINITIONS

Suspension of studies is defined as the formal introduction of a pause in a Learner's studies during which they are not required to engage with their studies. No definitional distinction is made between leave and voluntary suspension and the terms are used interchangeably.
